Terms & Conditions

In consideration of IFIC Bank Limited (hereinafter called "the Bank" unless the context otherwise requires where such expression shall mean and include its successors and assignees) allowing me/us, (hereinafter referred to as "The Customer" unless the context otherwise requires where such expression shall mean and include successors and assigns) to apply for the loan facility (the "Facility") under 'IFIC' Banijjik Bastu Rin' program I/We agree that I/We shall be bound by the following terms and conditions:

- 1. The Facility shall be made available to the Customer from the date of the Bank's acceptance of the Banking Arrangement Letter by the Customer until such time as stipulated in relevant letters and this Facility shall be a continuing one until full adjustment with the Bank with interest and other charges.
- 2. The above Facility will be made available to the customer subject to a Clean CIB report from Bangladesh Bank and compliance of Bangladesh Bank formalities (if any).
- 3. As per Govt. rules the bank will realize regulatory charges (VAT, Tax, etc.) on all sorts of commission & fees for the services.
- 4. Customer will not use the Facility for any purpose other than those for which it is granted.
- 5. Customer hereby confirms that Customer is not engaged in activities that may be considered by the appropriate authority (ies) as money laundering and the Bank may safely accept such confirmations as authenticate and true.
- 6. Customer cannot prepay any part or whole of the Facility within 12 (twelve) months from the date of the first installment.
- 7. Any repayment or prepayment of Facility whether in part or full will be attributable first to cost, charges and expenses, then to interest which has accrued on the Facility and then to the principal.
- 8. All fees, charges and other costs including legal fees incurred in connection with this Facility and security documentation will be paid by the customer.
